## Voters Guide for the November 2018 Elections

This guide is designed around the Social Principles of the UMC. Its intent is to provide UMC members with a benchmark to assess all candidates for Federal and NC State elections and their voting records or public policy and social policy positions against the similar positions taken by the UMC as described in the Book of Resolutions and the Social Principles (SP).

\* This guide lays out a summary of some resolutions and positions in the structured order of the Book of Resolutions and Social Principles. It will cover only those issues that are currently factors in this election cycle.

\* Gather information about all candidates and their public policy positions and compare them with the summary descriptions. http://www.ncleg.net/representation/WhoRepresentsMe.aspx

\* Go to <u>www.votesmart.org</u> and <u>https://www.govtrack.us/congress/members/NC</u> for positions of elected representatives. Go to the websites of new candidates for their positions on issues.

\* Add the names of the candidates in the columns provided and simply mark with a check mark if the positions of the candidate is similar to that in the Social Principles or with an X if it does not.

\* Decide which candidate more closely aligns with UMC Social Principle. Ask, which candidate best reflects the spirit and intent of the Social Principles.

\* Ideally as a UMC member you would seek to vote for candidates who reflect positions similar to the Biblical and Gospel narrative and of the UMC's position on public policy issues.

<b>Bullying</b> Supports legal and child management practices in schools to eliminate all forms of intimidation			
and bullying. Advocate for improved social services in schools to coach, advise, and mentor teachers,			
administrators parents and children in ways to eliminate this form of abuse. Opposes political name calling and verbal bullying by politicians. Promotes civility and respectful political behavior.			
<b>Human Rights</b> In general, the UMC affirms the civil and human rights of all people regardless of the			
race, ethnicity, age, disability, gender, sexual orientation, economic status and social status. In so doing it			
affirms candidates who seek to prevent any law that discriminates against any person or that seeks to reduce			
any societal benefit because of these factors. The presence of public symbols that support past discriminatory			
practices should be removed to prevent their use as points of honor and adoration. Affirmative action to right			
long standing elements of discrimination in empoyment, education, social services and public life should be affirmed and continued.			
<b>Rights of Immigrants</b> Advocates for a just and fair Immigration system that enhances economic			
growth, creates economic opportunity for everyone and unites families. Advocates for more, not less immigration of skilled people to address the growing shortage of skills to enable all of the country's business,			
academic and public service institutions to remain competitive. Addresses the growing issue of			
undocumented immigrants in a fair and just way, particularly for families born in the USA, by advocating for			
DACA to be made law. Advocates against the indiscriminate arrest and deportation of law abiding			
undocumented immigrants and provide a legitimate path to citizenship. Advocates for improved immigration			
services to address the growing backlog of cases under review. Advocates for a more humane and empathetic			
approach to refugees and asylum seekers. Resists the growing hostility towards refugees and asylum seekers.			
Rejects the separation of children from their parents. Calls for the elimination of Detention Centers.			
Right to Health Care- HIV /AIDS; Mental Health Supports the creation of law and practice that			
provides every person with equal access to all forms of health care at a cost that is affordable for even the			
lowest paid person. Candidates who seek to reduce or eliminate such access or the provision of health care			
services are NOT prefered. Enhance health care research, mental health services, public health services, and			
other societal health practices. Candidates who see health care as a basic human right are prefered. Protects			
social and health care services like Food Stamps and Medicaid for NC children. Supports extending Medicaid			
under the ACA in NC. Resist and advocate against the reduction of retirement and medical benefits in all			
public institutions by Federal and State legislatures.			
THE ECONOMIC COMMUNITY			
Work and Leisure Supports living wage, job creation, social measures to protect safety, leisure time,			
equitable pay and division of resources; support education; workers rights; anti-monopolies. Supports "Just			
Cause" employment practices. Supports the call for a livible minimum wage of \$15/hour			
Consumption Supports environmentally responsible production and consumption; anti-worker			
exploitation of any type; promotes Fair Trade Certified goods; living wages; quality of life takes precedence			
over higher productivity; stand against harmful economic, social and ecological practices.			
Foreign Workers Ensures that foreign workers enjoy economic, educational, social benefits and			
employment protections as enjoyed by other citizens			
<b>Corporate Responsibility</b> Support transparent reporting of corporations' impact on workers,			
suppliers, vendors, customers, the communities in which they do business, and the earth.			
<b>Finance</b> Supports banking regulations that prevent usurious interest; require lending institutions to be	1	Ī

THE POLITICAL COMMUNITY			
Basic Freedoms and Human Rights Protection of basic human rights- freedoms of speech, religion,			
assembly, communications media, petition for redress of grievances w/out fear of reprisal; right to privacy			
and guarantee of adequate food, clothing, shelter, education and health care. Reject domestic and foreign			
policies that endangers these rights for any peoples. Supports the right of individuals to peaceful non-violent			
dissent of unjust laws when acting under conscience and after exhausting all legal recourse.			
Church and State Relations Supports separation of church and state; Against prayer or worship in			
public schools. Should not promote particular religious belief that discriminates or is prejudicial to any person			
or group.			
<b>Education</b> Supports free public education for all K-12 children. Supports higher funding for all NC public			
schools, removal of all school segregation strategies; commited to higher teacher salaries. Rejects the			
siphoning of funds from public schools over to charter and private schools. Committed to removing financial			
barriers to church-related and other independent institutions of higher education. Supports the right for			
public and independent colleges and universities to exist, and edorses public policies that ensure access and			
choice and do not jeopardize separation of church and state. Supports academic freedom for all members of			
the academic community.			
Criminal and Restorative Justice Supports government measures designed to reduce and eliminate			
crime within the rule of law. Reject any and all careless, callous, or discriminatory enforcement of law and			
decry the use of law enfocement measures used for the purpose of revenge, persecution or intimidation for			
those whose race, appearance, lifestyle, economic condition or beliefs differ from those in authority. Rejects			
all court fees and incarceration resulting from non-payment of court fees which discriminate against the poor.			
<b>NC Constitutional Amendment proposals</b> Following a review of all six proposals, giving			
consideration to their impact on good government, equity and potential future societal needs, it is			
recommended that these proposals be <b>rejected.</b>			
THE WORLD COMMUNITY.			
<b>Nations and Cultures</b> Works through foreign policies to hold all nations accountable for unjust			
treatment of their citizens and others living within their borders and stands for justice and peace in every			
nation.			
<b>National Power and Responsibility</b> Supports efforts to develop a more just international economic			
order in which limited resources of the earth will be used to the maximum benefit of all nations and peoples.			
Supports adherence to international human rights agreements.			
War and Peace Rejects war as an instrument of national foreign policy and works to challenge and stop			
militarization of societies. Believes the manufacture, sale, and deployment of armaments must be reduced			
and controlled. Condemns the production, possession, or use of nuclear weapons. Endorses general and			
complete disarmament under strict and effective international control.			
Justice and Law Endorses the United Nations and related bodies, the International Court of Justice,			
and the International Criminal Court (ICC). Rejects the recent move to withdraw from the ICC and other			
international institutions. Advocates for more aggressive role in the development of international arbitration			
of disputes and actual conflicts among nations by developing binding third-party arbitration.
