## MEF GUIDELINES

- 1. Aid may be granted to students during their junior or senior year of undergraduate education, and in each year of their seminary years while working on their basic degree for ordination.
- 2. Applicants must be **Certified Candidates** (appeared before and approved by their District Committee on Ordained Ministry)
- 3. Students must be enrolled as "Full time" (12 credit hours undergraduate; 9 hours graduate) per semester

- 4. Students must attend a University Senate Approved school. A list of these schools is found at <a href="https://www.gbhem.org/education/university-senate/list-approved-schools">https://www.gbhem.org/education/university-senate/list-approved-schools</a>
- 5. Students must maintain an overall "C" average throughout their academic career. A transcript must be submitted to the Office of Ministerial Relations after each semester (email to <a href="mailto:omrsubmissions@nccumc.org">omrsubmissions@nccumc.org</a>)
- 6. Students must intend to serve in the North Carolina Conference, or within the Connection, for at least five (5) years following graduation.
- 7. Students must participate in one Personal Finance / Debt Management course and provide confirmation to the Office of Ministerial Relations (Form found on the OMR Website at <a href="https://nccumc.org/ministerial-relations/equipping/resources-for-seminarians/">https://nccumc.org/ministerial-relations/equipping/resources-for-seminarians/</a> and may be emailed to omrsubmissions@nccumc.org)
- 8. Aid may NOT be extended to graduate students in Ph.D., D.Min, Th.M., or other degrees beyond the basic degrees.
- 9. Applications are to be submitted annually and will be reviewed in the late Spring by the MEF Scholarship committee
