

A. Present Churches

BELLEMONT: On State Road 49 two and a half miles south of Burlington; Founded in 1883 according to local church information; Earliest deed September 17, 1887, Book 13, Page 163; Formerly Methodist Protestant; Membership 434.

BETHEL: On County Road 1587 near the intersection of County Roads 1002 and 1593 four miles north of Burlington; Founded in 1800 and named Pyle's Meeting House according to a church history; Earliest deed January 26, 1849, Book 1, Page 50; Membership 158.

* BETHEL: On County Road 1004 three and a half miles northeast of Snow Camp. Founded in 1836 when services began to be held in a log dwelling known as the Bobbet House according to a printed history; Earliest deed December 13, 1841, Book 30, Page 218 in Orange County Registry; A later deed February 21, 1874, Book 24, Page 101 recorded in Alamance County; Formerly Methodist Protestant; Membership 273.

* BURLINGTON, DAVIS STREET: 606 East Davis Street; Founded as First Methodist Protestant Church in 1890 according to a printed history; Earliest deed April 6, 1892, Book 15, Page 289; became Davis Street Church in 1939; Membership 1,028.

* BURLINGTON, EMMANUEL: 2331 La Vista Drive; Founded June 8, 1969 as a merger of Webb Avenue (founded 1893) and Trinity (founded 1952) and named Emmanuel July 7, 1974 according to a printed history; Earliest deed is for Webb Avenue Church which sold a lot March 11, 1904, Book 25, Page 235; Earliest Trinity Church deed May 29, 1952, Book 208, Page 506; Earliest Emmanuel Church deed November 5, 1968, Book 381, Page 252; Membership 709.

* BURLINGTON, FAITH: 1732 West Davis Street; Founded as Glen Raven Church September 7, 1907, became Faith in 1958 according to a local church history; Earliest deed is for Glen Raven Methodist Protestant Church May 13, 1918, Book 68, Page 2; Membership 302.

BURLINGTON, FRONT STREET: Corner of Hoke Street and Front Street; Founded in 1888 according to a church history; Earliest deed January 5, 1888, Book 13, Page 271; Membership 2,034.

* BURLINGTON, GRACE: 1899 Wilkins Street; Founded September 8, 1955 according to local church records; Earliest deed August 1, 1955, Book 237, Page 399; Membership 359.

BURLINGTON, SAINT PAUL: 607 Trail 2; Founded as Fountain Place Methodist Protestant Church by 1922 according to a church deed; Earliest deed December 19, 1922, Book 79, Page 544; Became Saint Paul on September 18, 1955 according to local church records; Earliest Saint Paul deed March 14, 1957, Book 258, Page 542; Membership 301.

* BURLINGTON, WEST BURLINGTON: 730 Kivett Street; Founded November 2, 1924 as a result of a January 18, 1917 organization of a Womans Missionary Society by Miss Agnes Stewart of Front Street Methodist Church according to a church history; Earliest deed is for West End Methodist Church of Burlington December 19, 1924, Book 84, Page 101; Membership 559.

* CEDAR CLIFF: On County Road 2176 just off State Road 87 one and a half miles north of Saxapahaw; Founded in 1885 as Wesley Church according to a church history; Earliest deed April 20, 1904, Book 25, Page 394; Formerly Methodist Protestant; Membership 217.

CHRIST: On State Road 87 two and a half miles south of Interstate 85; Founded January 1, 1959 according to church records; Earliest deed December 28, 1957, Book 258, Page 156; Membership 82.

* CONCORD: On County Road 1005 two miles west of the Orange County line; Founded in 1832 according to a church history; Earliest deed October 15, 1835, Book 27, Page 62 in Orange County Registry; Formerly Methodist Protestant; Membership 204.

FAIRVIEW: Just off State Road 87 in the Community of Ossipee; Founded in 1883 according to a Conference history; Earliest deed August, 1884, Book 17, Page 490; Formerly Methodist Protestant; Membership 214.

* FRIENDSHIP: On County Road 1130 West of State Road 49 six miles south of Burlington; Founded in 1834 according to a church history; Earliest deed August 16, 1856, Book 4, Page 478; Formerly Fogleman Schoolhouse; Formerly Methodist Protestant; Membership 431.

● GRAHAM, FIRST: 303 North Main Street in Graham; Founded July 12, 1896 according to a printed history; Earliest deed November 16, 1896, Book 19, Page 113; Earliest deed for Methodist Protestant Church November 16, 1897, Book 19, Page 285; These two churches merged November 12, 1939; Membership 1,051.

* HAW RIVER: On Church Street in Haw River; Founded in 1883 according to local church information; Earliest deed is for the Methodist Protestant Church of Haw River January 10, 1888, Book 13, Page 75; Earliest deed for Holts Chapel M. E. Church, South November 30, 1894, Book 17, Page 82; These two churches merged in 1942; Haw River was a preaching appointment on the Chatham Circuit July 23, 1833 at which time a Quarterly Conference was held there; An early church was in the area by 1838 according to a deed September 26, 1838, Book 28, Page 377 of Orange County Registry; Membership 381.

- HEBRON: On County Road 1007 two miles south of Interstate 85 at the Orange County line; Founded in 1850 according to local church information and a cornerstone; Earliest deed December 1, 1879, Book 142, Page 542, recorded on May 18, 1943; A later deed November 22, 1906, Book 33, Page 562; Membership 313.
- * MEBANE: Corner of Holt Street and Fourth Street in Mebane; Founded as The Methodist Protestant Church in 1900 according to a church history; Earliest deed is for an M. E. Church, South, for a parsonage March 28, 1901, Book 22, Page 471; Both church and parsonage were built on this property and deeds in November, 1919, Book 69, Pages 343 and 345 separated the two; Earliest Methodist Protestant deed December 26, 1902, Book 24, Page 461; First Methodist Protestant Church and Central Methodist Church, South merged in 1941; Membership 825.
- * MOUNT HERMON: On County Road 2321 one mile southwest of State Road 87 seven miles south of Graham; Founded as a Methodist Protestant Church in 1829 according to a church history; Earliest deed reported to be November 7, 1834, Book 27, Page 145 in the Orange County Registry for one acre of land sold by Henry Foust and November 7, 1834, Book 27, Page 147 in the Orange County Registry for two acres sold by George Albright according to a church history; Membership 528.
- * PHILLIPS CHAPEL: On County Road 2153 just off State Road 54 seven miles southeast of Graham; Founded in 1849 according to local church information and a stone marker; Earliest deed 1860, Book 16, Page 451 recorded March 22, 1894; Membership 209.
- * ROCK CREEK: On County Road 2365 six miles north of the Chatham County line; Founded in 1836 according to a printed history; Earliest deed July 9, 1841, Book 35, Page 542 and recorded September 24, 1908; Formerly Methodist Protestant; Membership 136.
- SAINT LUKE: Community of Glenco just northwest of Burlington; Founded February 12, 1961 according to church records; Earliest deed August 18, 1961, Book 293, Page 477; Glencoe Methodist Church members merged with Saint Luke in 1961; Membership 121.
- * SALEM: On County Road 2142 at the intersection of County Road 2150 two and a half miles north of Saxapahaw; Founded between 1780 and 1790 according to tradition and became Methodist affiliated by 1822 according to a printed history; Earliest deed for church property September 13, 1809, Book 13, Page 350 in Orange County Registry as Salem Meeting House to the deacons of the Presbyterian Church; Became Methodist Protestant in 1828; Membership 312.

* SAXAPAHAW: Community of Saxapahaw; Founded as Saxapahaw Union Church about 1890 according to a church history; Earliest deed July 29, 1891, Book 15, Page 39; Property used for services for Methodist Protestant, M.E. Church, South, Quaker and Presbyterian groups; Became Saxapahaw Methodist Church in 1939; Membership 202.

SHILOH: On State Road 87 one and a half miles south of the Caswell County line; Founded about 1825 according to Historical Sketches of Churches, Duke University Library; Earliest deed may be November Book 29, Page 379 in Orange County Registry; Another deed November 21, 1895, Book 17, Page 561; Membership 262.

SWEPSONVILLE: On East Main Street in Swepsonville; Founded in 1887 according to local church information; Earliest deed November 17, 1887, Book 13, Page 28; Formerly Newlin Methodist Church; Membership 348.

ELON COLLEGE: Earliest deed March 6, 1922; Book 78, Page 415; Methodist Episcopal, South.

GRAHAM: Earliest deed November 16, 1897; Book 19, Page 285; Methodist Protestant.

HAW RIVER: Earliest deed November 30, 1894; Book 17, Page 82; Methodist Episcopal, South.

MEBANE: Earliest deed November --, 1919; Book 69, Page 343; Methodist Episcopal, South.

MOUNT VERNON: Earliest deed December 14, 1905; Book 31, Page 49; Methodist Episcopal.

QUEENS CHAPEL: Earliest deed April 25, 1905; Book 27, Page 594; Methodist Episcopal.
