

This study of the history of Burgaw United Methodist Church has given us an ever greater appreciation of those who have gone before us, bringing the Church to its present state.

In writing the history we decided to use Church Records verbatim as far as possible. Quarterly Conference Minutes are almost complete; Church Board Minutes less so. United Methodist Women records are complete after 1933. Sunday School and other organization records are scarce. We have tried to do our best with materials available. If we have omitted some events or names that should have been included, we are sorry, but memory is a poor substitute for a written record.

Membership rolls are not included because Church has fairly recent directories and a revision is in prospect.

EARLY BEGINNINGS

The Methodist Church, South, of Burgaw, according to available records, was formally organized and assigned a pastor in December, 1897. But we know that Methodism came to this area more than a hundred years ago, and believe that the Church in Burgaw had its genesis in the Macedonia Methodist Church, located just outside present town limits.

Minutes of the Session, Hopewell Presbyterian Church, 1860-1900, page 33, May 11, 1874 have this notation: "Mr. Jere H. Murray and wife Martha Murray received as members from Macedonia Methodist Church, and their names enrolled." (Information furnished by Wayne S. Arnold)

Mrs. Martha Jane Jordan, born in 1889, remembers passing the old, rotting building, surrounded by sycamores, as a youth on her way to Burgaw. She remembers that her husband's grandfather, Jessie P. Jordan was a Methodist preacher, Burgaw Postmaster 1867, preached at Macedonia Church, which was located on present highway 117, approximately where L. C. Houghton's restaurant is. An old map also shows this location. Mrs. Jordan also remembers hearing that John Brothers was often called on to pray. One Sunday the conscientious man said he couldn't pray because he and his wife had an argument that morning.

We believe that a group of worshippers at the little Macedonia Church, (possibly made of logs) became the nucleus of a church in the new town of Burgaw. We know that several members of the Brothers family were listed in the earliest Burgaw Records, and we know that some trustees named in the Wilmington-Weldon Railroad deed to the Methodist Episcopal Church, South, of Burgaw for a site, and trustees named in the deeds transferring Macedonia Church property, were the same.

On 1 November 1884 the Wilmington and Weldon Railroad Company deeded to the trustees of the Burgaw Methodist Episcopal Church, South, S. S. Satchwell, F. H. Bell, W. J. Herring, John E. Durham and John R. Paddison a lot for a house of worship in consideration of ten dollars. The parcel of land was situated on the east side of the railroad, near the Courthouse, at or near the station called Burgaw, bounded on north by Wilmington Street and on the East by Cowan, (240 x 181 ft.). The deed was signed by R. R. Bridges, President and two directors. It was filed for registration, December 31, 1885.

It seems reasonable to think that with this tract of land in hand, that Methodists in the area would get together, decide to sell the old church and work toward building a new one.

The Macedonia deed could not be found. Sterling Allen and wife Annie for one dollar consideration, deeded the site of Macedonia Methodist Episcopal Church, South to trustees Grattan Williams, S. S. Satchwell, J. E. Durham, D. H. Armstrong and John R. Paddison a tract of land known as the Macedonia Church place, 2 acres more or less. Registered June 25, 1896. Deed given in lieu of a deed heretofore given the trustees of Macedonia Church which said deed was lost, mislaid or destroyed. Book K, p. 209. Deed of conveyance, March 1, 1886 by and between Grattan Williams, Dr. S. S. Satchwell, John E. Durham, D. H. Armstrong and B. G. Crisp, trustees for and in behalf of the Methodist Episcopal Church, South in consideration of forty-eight dollars sold to Rachel E. Wright the tract of land on the Duplin Road known as the old Macedonia Church. Acknowledged for execution April 1886 before T. J. Armstrong, J.P. and filed for registration and recorded in October, 1905.

Open air evangelistic services on the Courthouse Square led by Rev. A. B. Crumpler and Rev. J. T. Kendall added enthusiastic numbers to the Methodists who had no building, but met in the Academy, close by the Presbyterian Church and sometimes in that Church. There is a roll dated 1896 of members who were baptized by the Reverend Kendall. Some of these may have come from surrounding areas before the outlying Churches, Burgaw Creek (later Jordan's); Crumpler's Chapel (Trinity); South Washington, (Watha); Zion and Epworth were organized.

Burgaw was planning for a Church building. The trustees, R. I. Durham, E. B. Jordan, J. T. Collins, J. B. Moore and E. T. Rivenbark in a deed dated July 5, 1898 bargained with M. M. Moore and his wife, Mary G. Moore to exchange the Church's tract of land on Wilmington and Cowan Streets for the Moore's tract of land (480 x 189 ft.) on Bridger, Walker and Ash. Registered July 13, 1898. This was a large tract, and not foreseeing today's need for spacious parking room, the northern 1/4 of block was sold to J. B. Black in 1902.

THE BURGAW UNITED METHODIST CHURCH

The first Burgaw Methodist Episcopal Church, South was a frame building with two front doors, a bell tower and a steeple. The first service in the new church was held in April, 1905 by the Rev. Frank W. Sandford. The church was dedicated by Bishop J. C. Kilgo.

The first Church was used until 1929 when it was replaced by a brick structure begun when Rev. E. G. Overton was pastor. Unfortunately the Great Depression hit, and it took some years to complete and furnish the building, despite all the suppers of oyster soup and chicken salad that the church ladies could serve to the church and towns people.

Since that time many improvements have been made. A vestibule has been added, and the Sanctuary made more beautiful. Symbolic stained-glass memorial windows have been added; including a specially designed circular window in the choir loft and a Madonna window over the vestibule inner door to the Sanctuary.

Memorial light fixtures, new pews, crimson pew cushions, and carpet, have been added. A Baptismal Font and a Stephenson organ are other memorials, as are the brass urns and tall candelabra used for special occasions, and many of the hymnals. Memorial chimes were installed over the Sanctuary in 1976. (All memorials are listed in the Memorials Section, with accreditation.)

THE EDUCATIONAL BUILDING

Memorial funds also helped build the Multi-Purpose building planned under the leadership of the Rev. Charles E. Owens. Constructed on the site of the old parsonage, this building contains pastor's study, classrooms, attractive big rooms for kindergarten and nursery, a large Fellowship Hall with elevated stage and two ante-rooms. Adjacent to the Fellowship Hall is a well-equipped kitchen. The multi-purpose building is true to its name. It serves many needs, not only for the Church itself, but for the larger community.

While the new building was undergoing construction, the back two story portion of the main church building was remodelled. There were several small classrooms downstairs; three classrooms, a kitchen, recreation hall, and two restrooms upstairs. During the remodelling some rooms were made larger and the space more usable.

THE PARSONAGE

The first parsonage was on the site of the second parsonage, and was moved across the street when the second was constructed during the pastorate of Rev. L. M. Chaffin, in 1917-1918. This was a rambling frame structure with wide porches. Then in 1957 after the circuit was divided, Burgaw and Watha built a modern brick veneer dwelling just north of the Church. Planned while Rev. Grady Kinley was pastor, it was built during the pastorate of Rev. C. Frank Grill, at a cost of \$22,675.58. Burgaw paid 85% of cost, and Watha paid 15%. The Board of Missions gave \$1,000.00.

THE PASTORS

The history of the Burgaw Church is largely the story of its pastors. Every pastor advanced the work of the church in his own special way. They have led this Church along with others on the Burgaw Charge, or Circuit, for more than eight decades from the beginning as the Methodist Episcopal Church, South to the combining with Northern Methodist Episcopal Church into The Methodist Church in 1939. Then in 1968 came the union of The Methodist Church with the Methodist Protestant Church, the United Brethren and the Evangelical Association into one body, the United Methodist Church.

Dedicated, able pastors led the membership not only through the changes in church organization but through great changes in the lives of area people, of the American people and of the world.

Our first detailed records begin with the pastorate of Rev. Frank Sandford who served eight widely separated churches. These included Rocky Point, Herrings, Zion (near Atkinson), Burgaw Creek (later Jordan's), Trinity, Wallace, South Washington (Watha). The Church at Burgaw was smaller than those at Rocky Point and Wallace. According to the record, the entire circuit paid the preacher \$59.72, and the presiding elder \$12.00 for the quarter ending April 29, 1905. Money was scarce at that time, but it is certain that the country people helped feed the minister and his horse. One has to admire those intrepid men who travelled every Sunday to some point on the circuit over muddy, or dusty, bumpy roads! They were surely filled with a desire to serve their God.

Along with people of the churches, pastors have come from the time of eight churches to two Charges, with Burgaw and Watha on the Burgaw Charge, and Herrings, Rocky Point and Jordans on the Rocky Point Charge; from horse and buggy days to comfortable cars, from fireplace heat in a drafty dwelling to modern wellequipped homes. From sorry, poorly heated church buildings to good buildings with beautiful sanctuaries and space for many activities. From a salary pittance to a decent living with good retirement benefits.

Despite the better times materially, the pastor and his people have many problems not easily solved. It seems that every advance in civilization bears a concomitant price. For example, manufacturing plants bring jobs, they also pollute the environment; nuclear bombs deter war, they also threaten mankind. Television brings information and recreation to every home, it also exposes children and youth, in fact all of us, to violence and standards of conduct not normal in the Christian home. The many social problems rampant today - drug use, child abuse, illicit sex, are only a few. These problems plague us all, but perhaps most of all the minister whose call is not only to preach the word, but to counsel and comfort as best he can. No, the minister's problems are no less burdensome than in 1905. Perhaps we have never needed a consecrated man of God more than today. For the Church of God must go on. It is the Hope of the World. For the world will never know peace, until it knows the Prince of Peace.

Following is a listing of pastors who have served God on the Burgaw Charge. Let it be said that almost invariably they were accompanied by wives who also gave unstintingly of their own service when in Burgaw.

CONFERENCE MINUTES

1905, Feb. 4: Rocky Point.

Present: Presiding Elder Rev. M. Bradshaw; Pastor in Charge, W. F. Sandford; Stewards, R. I. Durham, L. Learned, J. E. Durham, Robert S. Futch; and SSS, J. N. Gibbons of Wallace. G. F. Jordan, Recording Steard.

The Charge Report showed 330 members, 8 additions on profession of faith, 4 additions by certificate, 10 removals by death, certificate or other, 3 adults baptized; value of 6 houses of worship \$3,000; value of 1 parsonage \$500.

1905, April 29:

Rev. Sandford made the following report: "I am pleased to report that our Church building at Burgaw was opened for services last Sunday morning. It has been completed, with the exception of the furnishings which will be put in as rapidly as possible."

"The missionary spirit is taking hold of the people. The entire assessment is provided for in cash and subscription."

Charge Stewards and Trustees were:

Finance apportionments for year were: Pastor \$550, P. E. \$91, Bishops \$11, Conf. Claiments \$30, Foreign Missions \$60, Domestic Missions \$50, Education \$32, Church Extension \$28, Delegates to Gen. Conf. \$5, P & L \$5.

Expenditures were \$118.70 for repairing or furnishing Churches, \$73.40 for Parsonages.

There were 49 subscribers to Conference Organ.

Paid during quarter for support of ministry: Burgaw, \$4.20; Rocky Point, \$6.36; Wallace, \$22.50; Zion, \$.43; Burgaw Creek, \$2.00; Total, \$35.49. Pastor \$29.58; P.E. \$5.91; Total \$35.49.

Other Business: Ellis Gurganus elected Treasurer-Trustee for Zion. J. Hall McGowan added to building committee at So. Washington. Only 3 Sunday Schools in active operation: Wallace, Herrings, Rocky Point. Mission school organized at Stoney Run under care of Bro. J. W. Brown - fills a great need.

1905, Sept. 30: Wallace.

Paid to support of Ministry past quarter: Rocky Point, \$34.35; Herrings, \$26.07; Burgaw, \$10.69; Burgaw Creek, \$8.70; Wallace, \$14.50; Watha, \$.76; Trinity, \$7.40; Zion, \$4.84.

O. P. Johnson added to the board of Parsonage Trustees. A motion adopted "that the Parsonage Trustees be appointed a committee to erect a new parsonage with power to dispose of the old building to the best advantage."

SSS's: J. E. Durham, J. N. Gibbons, J. F. Herring, D. W. Murray, R. I. Durham. No Epworth Leagues. 180 persons attending SS.

1906, August 4: Burgaw Creek.

Sandford: "Home missionary territory - St. Helena, a colony of some fifty Italians, is without a spiritual adviser."

Report of Committee on Records and Registers: "Burgaw, Burgaw Creek, Zion and Watha have no registers." No records have been kept.

1908, February 15: Burgaw.

W. L. Cuninggim, P.E.; J. J. Barker, P.C. Present: J. S. Westbrook, O. P. Johnson (St.), R. I. Durham.

Jordan's listed for 1st time - not Burgaw Creek. Missions emphasized - Barker wanted to raise 5¢ per member for American Bible Society. Preacher was to get \$900.00.

1909, 2nd Quarterly Conf: Wallace.

Supplement to Minutes: J. J. Barker - "with the bare exception of Wallace there has been but little real interest manifest in the Pastor and the Church work in general. The flooded condition of crops last year may explain this condition of things."

1910, March 7: Rocky Point.

Lance, P.C. Paid to support of Ministry: Rocky Point, \$29.35; Trinity, \$5.92; Watha, \$6.00; Herrings, \$12.63; Epworth, \$10.77, mentioned for 1st time; Burgaw, \$25.88; Jordans, \$13.28. *Wallace not mentioned.

1910, June 17: Jordan's Chapel.

Epworth League organized in Burgaw, about 50 members doing good work. (Rocky Point lost it's Pres. since A. N. Rhodes was at Burgaw, and was doing poorly.) Burgaw officers: Pres., C. M. Lance; lst VP, A. N. Rhodes, 2nd VP, Mrs. J. G. McNeal; Sec'y, B. E. Seal; Treas. Estelle McLendon; Epworth Era Agent, E. Ebert. Children's Day will be observed in all churches.

Paid to support of Ministry: Rocky Point, \$48.74; Trinity, \$12.65; Watha, \$20.69; Herrings, \$26.67; Epworth, \$8.13; Burgaw, \$56.57; Jordan's, \$6.42.

Education: We have one pupil, Annie Dell Durham who has been in school at "G. F. College" this year. Our public schools are fairly well patronized.

Stanley Johnson, McNair Johnson had joined on profession of faith.

1911, April 29: Epworth Church.

C. M. Lance, Pastor. L. Learned and O. P. Johnson attended. Robert I. Durham was secretary.

1911, October 28: Burgaw.

C. M. Lance, Pastor. "Burgaw paid in full their part of the Sandford debt on the parsonage."

1914-1915 Burgaw Charge, Wilmington District, N. C. Conference.

Whedbee's Report: "The Woman's Missionary Society at Burgaw is doing fine work. It is less than one year old, yet they have enrolled 19 members and raised \$15.00. They have observed the day of prayer and are doing splendid work."

Whedbee also reported: "I will have to make the report as I have always done. 7 Churches, 1 parsonage. I have understood the parsonage is insured for \$500 - have failed as yet to find who holds the policy."

On motion of P.C. moved that J. G. McNeal was elected Chm. of a committee of three, L. Learned, and R. I. Durham to look into rebuilding the parsonage at Burgaw and all interests thereto.

"We have secured subscriptions amounting to about \$400 for the purpose of building a new parsonage and between \$75 and \$100 of it has been paid. It is a cash proposition."

1918, August 10:

Fred Dees was elected Trustee in place of O. P. Johnson, deceased; J. L. Bowden in place of R. I. Durham, deceased. A. H. McLendon was elected as a member of the Parsonage Committee in place of R. I. Durham, deceased. R. Bell, Rec. Sec.

"It looks like now we may succeed in building a parsonage." L. M. Chaffin.

"We have not been able to find the Register at Burgaw. There is a Register for the entire Charge but it has not been properly or correctly kept."- L. M. Chaffin.

1919, November 9:

The following Resolution was adopted: Resolved that the Trustees

of Burgaw Charge be instructed and empowered to execute a mortgage and refunding bond to the Board of Church Extension of the M. E. Church, South for the sum of \$1000.00 donated for building parsonage.

1919, January 24: Burgaw.

L. M. Chaffin, Pastor; J. H. Shore, P.E.; K. D. Futch elected Secretary. Present for Conference: Chaffin, K. D. Futch, L. Learned, A. H. McLendon, H. M. Page, E. O. Herring.

Apportionments for year for Preacher's Salary - \$1000.00: Burgaw, \$475; Herrings, \$240; Jordan's, \$150; Trinity, \$60; Watha, \$180; Zion, \$25.

K. D. Futch elected Trustee of Epworth in place of J. G. Brown, deceased. Received on Profession of Faith, Mary L. Bryan and Emma P. Bryan.

1919, April 19: Herring's Chapel.

The Trustees of Epworth Church are instructed to sell the said Epworth Church, organ, Bible and stove, each to be sold separately and to the best advantage, and the proceeds to be applied to the furnishings of the Parsonage. The remainder to be divided equally between Burgaw and Herring's Chapel Churches. The new parsonage is now being built, and we hope within a few weeks to be able to move into it.

1919, July 11: Watha.

"The Parsonage Building Com. instructed in completing parsonage to install necessary sanitary closet on premises and pay for same out of parsonage fund. If there should be no funds, the said committee is empowered to lay an assessment on the Churches on the Charge necessary to pay for said closet."

1919, October 4: Burgaw.

L. M. Chaffin suggested to Conference the idea of discontinuing Trinity, and reported "The parsonage is nearly completed except painting and that was not provided for when we began to build it. In the present state of affairs if we stop there will be no debt. If we paint any part of it there will be that much indebtedness."

1920, January 23: Burgaw.

Pastor's salary to be \$1400.00 - Burgaw, \$600; Watha, \$225; Herrings, \$300; Jordan's \$175; Trinity, \$60; Zion \$40.

Elected SS Supts: T. J. Betts, R. J. Herring, G. W. Walker, Arthur Anderson, L. B. Saunders, Mrs. Eunice Owens. Trustees elected for Burgaw: A. H. McLendon, Joe L. Bowden, John W. Bowden, Dr. Fred Dees. Resolution in memory of Lyman Learned. (In Book)

1921, June 10: Watha.

"The Men's Bible Class at Burgaw Sunday School now supports a little boy in the Orphanage at Raleigh." Students in Church colleges: Herbert Herring and David Johnson at Trinity. Stanley Johnson attended Wake Forest.

A monthly newsletter is sent to those we have located and to local members of the Congregation. The charge is operating not only at a record membership but a record budget. A policy committee has been appointed and a separate record book will contain written policies which, once approved by the Official Board will be binding and add to the efficiency of the Church program.

Marie Blackmore, Pres. MYF. MYF has 12 members. Special Easter, other Church programs. Helped raise Parsonage Fund.

Pastor's Report: Three special projects at Burgaw: (1) A memorial outdoor bulletin board of a permanent type. (2) Study groups being formed to promote stewardship and tithing. (3) Membership drive. Church will participate in March United Evangelistic Mission. Rev. C.C. Phillips, pastor of South Point Methodist Church, Belmont will be the Evangelist in Burgaw. Both churches were above average in benevolence giving, continue to support conference causes and meet their current budgets while making regular payments on parsonage project.

Brown to this office. Action approved unanimously.

WSCS Reporting, Mrs. Jep Casey, Pres. Sent to Conference treasurer for Missions, \$467.90; Plastics party for Parsonage Fund; three studies, average attendance 17.

Pastor Grill reporting: "We have had the largest net gain in membership in five years. This is the first time the membership (of the Charge) has reached 300. The community and members of the Burgaw Charge deeply regretted the death of Jepthah Casey, Sr. on December 17, 1957. Mr. Casey was a steward and trustee of the Burgaw Church. It was discovered during the stewardship and tithing emphasis that 30 persons on the Burgaw Charge tithe. The old parsonage was sold for \$300 cash. Indebtedness on the parsonage is now \$6900. Progress is being made in many areas including financial and numerical as well as a deepening of spiritual life."

Early, pastor of Grace Methodist Church as evangelist. Budget for the ensuing year will be \$9320. This does not include remaining indebtedness of \$3250 on parsonage."

MYF Pres. Ellen Caryl Futch reporting: "Plan to clear lot next to Church for recreation area. Sold light bulbs and stationery; visited shut-ins for prayer services, went Christmas caroling to shutins, hospital, jail and prison."

- 1948, Dec. 5: R. E. Walston, P.C. Letter from the D.S. was read asking that the pastor's salary be not less than \$3000.
- 1949, Feb. 2: C. L. Moore to make Layman's Day address. E. M. Thompson and J. T. Brown to assist with program. Mrs. Norma Rochelle and Mrs. Ellis Dees appeared before Board to get church yard leveled. The Board decided to install a furnace in Sept.
- 1950, October 15: A committee was to be appointed to explore the possibility of making Burgaw a station.
- 1951, Jan. 1: Mr. Moore made a motion to build a vestibule. Motion carried, and also a motion by Mr. Wells that we employ an architect to draw plans for, inside, outside, and part inside, part outside. Mary Bryan moved that the church windows be painted on the outside first of all. Carried. A drawing of the vestibule was to be at the church Mar. 11. After discussion of circuit splitting, Mr. Moore moved that the Burgaw circuit be split, the Burgaw church to become a station, and the other churches become a separate charge upon the following conditions: (a) That it meet the friendly approval of the churches on the circuit; (b) That the pastor's salary for the Burgaw Charge not be reduced from the present standard for the circuit; (c) That arrangements be made for another acceptable parsonage; (d) That a majority of the adult membership of the Burgaw Church affirmatively agree to splitting the circuit, and to the above conditions. Motion seconded by Bobby Dees and carried.

MUSIC IN THE CHURCH

Music has always been an integral part of Methodism. John Wesley's sermons stirred the heart, and conscience of England but it was Charles Wesley's hymns that swept the countryside, and left the people with deeply spiritual songs on their lips.

In America, George Whitfield, Frances Asbury, all the early preachers had their own sermons to deliver, but Charles Wesley's hymns were used well and often wherever believers met. Who could imagine an old-time outdoor revival or tent meeting without the vigorous singing of inspirational hymns? It was often the singing that drew the crowds to hear the gospel message.

Today, Methodists engage in few tent or outdoor meetings. There is no need; there are large attractive churches with comfortable pews. But the music is as important as ever. It establishes a worshipful atmosphere, and assists the minister in the service.

A choir has a large part to play in the success of any church. The Choir of the Burgaw Methodist Church does its part well. The members are faithful and dedicated, and their hard work shows in the beautiful specials and cantatas they present, as well as in the regular services.

We were fortunate to have Margaret Lee Betts as pianist before she married Gordon Cashwell and moved to Ingold. We have also been fortunate to have the services of Mrs. Florence Croom, organist for thirty-five years. Mrs. Croom retired in 1984, and the Church presented to her a beautiful inscribed placque and a love gift from the congregation.

It is the good fortune of the Burgaw Methodist Church to have Mrs. Mary Peedin, a trained musician, to direct the Choir. She also directs the children's choir. Both choirs add immeasurably to the inspirational quality of worship services.

Musical instruments are important too. The first church organ was a Williams installed in August, 1920. It was purchased with funds largely raised by Burgaw local taletnt, including J. T. Wells, Clifton Moore and Mary Barden. The young folk presented a play "Deacon Dubbs" in Burgaw, Wallace, Atkinson and Rocky Point for the organ fund.

A Stephenson organ was installed in the present church in 1954.

A memorial piano was placed in the Parsonage when purchased, but is now in the Fellowship Hall.

Mrs. W. M. Rochelle and the Whiteside Family gave a piano in memory of Marcellus Rochelle. It is in the Sanctuary.

Hymnals have been given in memory of various persons. (Please look in "Memorials Section" for further information).

All of us are indebted to those who use their time and talents to enrich the Church Services week after week, Sunday after Sunday.

SUNDAY SCHOOL

Sunday School, or Church School, as it is now termed, has always been important in Methodism, as in other Christian Churches. Bishop Francis Asbury established the first American Sunday School in Hanover County, Virginia in 1786. Wherever Methodist organized a church, they were urged to give regular religious instruction on Sundays. This was particularly important when preaching services were few, and it was the weekly Sunday School that held congregations together. Sometimes the Sunday School was in the morming, more often it was in the afternoon.

Sunday School, in the early days, in the Burgaw Methodist Church began at five o'clock in the afternoon in order not to conflict with the Presbyterian and Baptist Churches. Finally, a minister, concerned about the children who were tired by this time of day, decided to set an earlier hour in order to have a better study program.

A charter member of the Church, Mr. Lyman Learned was always on hand, doing what he could to help, from making fires in winter to ringing the bell all year. Mrs. Learned was also involved, as were the daughters, Louise, Lois and Annie Bell.

Another family constantly supportive was that of O.P. Johnson, Church Steward and Trustee. Mr. Johnson's sons acted as Sunday School Superintendents 1916 - 1920. Rachel Johnson taught in the Sunday School though she regularly attended the Presbyterian Church.

Sunday School Teachers in 1916 were: Mrs. Whedbee, Miss Rachel Johnson, Mrs. Lyman Learned, Mrs. Della Collins, Miss Louise Bernard, Mr. J. H. Burnett, Mr. Smithwick.

Mr. T. J. Betts took charge as Superintendent on Sept. 19, 1920; he also taught, and sang in the Choir. Other people who conducted Sunday School through 1926 were Fletcher Herring, J. F. Herring, H. L. Davis, Lyman Learned, Mr. J. H. Burnett, Mr. Smithwick. Mr. J. T. Brown became Superintendent and served faithfully for forty-two years. The Church installed a Baptismal Font in his honor when he retired. There were then a succession of acting Superintendents: Don Peterson, Huitt Reep, Joe Honeycutt, Elmore Howard. Cecil Bradshaw has been in charge of the Sunday School for several years. It may be said that Mr. Bradshaw has a remarkable record of attendance, hardly missing a Sunday since babyhood.

For many years, the SS report each Sunday listed the songs sung, the scripture, the subject, the weather, in addition to statistics of attendance. On November 27, 1927, six teachere were present and 62 scholars. The regular collection was \$3.53. The Thanksgiving offering for the Methodist Orphanage was \$42.00. Sad to say, though we have had better attendance in many years since 1927, in 1983 and 1984 it has not been large. On April 1, 1984 attendance was 61; offering, \$292.80. International lessons were always used in the early years, and the lessons, all on the same scripture, were adapted to different age groups. Elderly people today fondly remember the cards that they were given at Sunday School. Just right for a small hand to hold, the card bore on one side a brief Bible Story; on the other a reproduction of a famous painting illustrating the text. Children have had many different materials in later years, but none have been so well liked as the tiny cards!

Many of our adults have served in a teaching capacity over the years. Unfortunately we have no records of their service. We can only mention those who have served fairly recently or are presently serving.

The Men's Bible Class: E. M. Thompson, Clifton L. Moore, Willis Johnson. On August 7, 1966 the men voted to change the name of their class to the Clifton L. Moore Bible Class in memory of Judge Moore.

The Molly Bryan Bible Class was named for the mother of Mary and Emma Bryan who furnished the classroom in her memory. Mrs. Clifton L. Moore taught the class until her husband's appointment to the State Supreme Court when they moved to Raleigh. Mrs. E.M. Thompson taught for awhile, then Mrs. Eleanor Casey became teacher. She is assisted by Mrs. Norma Sawyer and Mrs. Clifton L. Moore.

The Junior Wesleyan Bible Class is taught by Mrs. Betty Futch, assisted by Miss Toni Shaffer.

The Owens Bible Class (Young Adults) is taught by Mrs. Margie Jones and John Federonko. The Young Adult Class II is taught by Mrs. Jean Greer.

Others who are now teaching include Mrs. Nellie Freed, Senior High; Mrs. Eva Paluck, Junior High; Janet Slate, 4th thru 8th grades; Mrs. Cathy Harrell, 1st thru 3rd grades; Mrs. Belinda Coates, Nursery 3 and 4 year olds; and Mrs. Grace Paluck, Nursery.

Others come to mind who have served in the Sunday School. Mrs. W. M. Rochelle, Mrs. W. H. Young, Mrs. Elmore Howard, Mrs. Joe Honeycutt, Mrs. Amy Blackmore, W. C. Blackmore, Mr. and Mrs. Vance Weibley, Mrs. Allen Wooten, Mrs. May Griffin, Mrs. Mickey King.

Each year the Church has a Vacation Bible School for the children, well attended and skillfully taught. The same persons mentioned above have helped with the Vacation Schools. For a period of time, Mrs. J. H. Burnett conducted a weekly Bible Study Hour for the children. Now the pastor, Rev. Lester P. Jackson and Mrs. Jackson meet with the Junior MYF on Friday afternoons. There are seasonal activities for the children, Easter egg hunts, a Christmas program and tree, picnics, etc.

A word must be said about the beautiful well-equipped nursery and kindergarten rooms happily filled with babies and tots after a long dearth of young children in the Church. It seems that the spirit of Mary Bryan must hover over these rooms where she spent so many Sundays from early womanhood until her death. Despite the fact that she taught in public school all week, she was always with the little children on Sunday. She loved them, and they loved her. The young ladies of the United Methodist Women, "Alumnae" of her Sunday and Public School classes named their unit "The Mary Bryan" Circle in honor of their beloved teacher.

Worthily following Miss Bryan's footsteps in the Nursery is Mrs. Grace Paluck, assisted by Mrs. John Paluck. Every Sunday these ladies are with the babies and tiny tots, rendering this great service to the parents and to the Burgaw United Methodist Church.

UNITED METHODIST WOMEN

The Women of Burgaw United Methodist Church have been organized for seventy years. At the 4th Charge Quarterly Conference, November, 1915, the pastor, Rev. Whedbee, reported that "The Woman's Missionary Society of Burgaw is doing fine work tho less than one year old. They have 19 members, and have raised \$15, and have observed The Day of Prayer."

There would not always be nineteen members of the young Society, but there would be some, and they were always actively working for missions and the local Church.

Preserved minutes begin with 1933. Three women, Mrs. Ellis Dees Biberstein, Mrs. Hazel Swinson Moore, and Mrs. Ruth Deaton Burnett were recognized for their faithful service in the Women's organization for over 50 years in the special Bicentennial program on June 24. The program was written by Mrs. Eleanor Casey and presented by Society members to portray the developing role of women in Christianity and the Methodist Church.

The Society has always had two paramount interests: Missions and the Local Church. Each year substantial contributions have been sent to the Conference Treasurer to be used on Mission projects in almost all of the forty eight States and Washington, D.C., in Central and South America, the Pacific and Caribbean Islands, and the continents of Africa, Asia and Europe.

Locally women have been involved in all church improvements, sometimes originating the ideas. We have co-operated with every pastor on church programs, providing leadership for our church women.

The ladies have had many fund raising projects for local work, including the publication of two popular cookbooks.

Women in the work force have brought about changes. More money is available for missions and local work; fewer fund raising projects are engaged in. It is not easy to have good attendance at numerous study classes, nor as easy to have many representatives at district and conference meetings.

But the Society remains strong, and dedicated to the spread of the Gospel and helping the needy. It will always be there to undergird the work of the pastor and the local church. It has come through the organizational changes attendant upon the combining of five Methodistrooted denominations, from Woman's Missionary Society to Woman's Society of Christian Service (1939) to United Methodist Women (1968). We are proud to be a part of this great organization.

BICENTENNIAL YEAR

The Burgaw United Methodist Church joined Methodist Churches all over America in 1984, celebrating the two hundredth anniversary of the organization of the Methodist Episcopal Church in Lovely Lane Meeting House in Baltimore, December 24, 1784. There sixty three circuit riding preachers met and elected their first Bishop, Francis Asbury.

The local Bicentennial Committee was named in October 1983. It is composed of Mrs. Eleanor Casey, Chairman; Billy King, W. C. Blackmore, Charles Rooks, Mrs. Mary Peedin, Mrs. Florence Croom, Vance Weibley, Mrs. Jean Greer, Willis Johnson, Mrs. Mary Jo Johnson, Mrs. Mickey King, Mrs. Betty Futch, John Federonko, Miss Janet Slate, Mrs. Joyce Wooten, and Rich Biberstein. The Committee met and decided that the various departments of the Church and Church School would present Bicentennial programs during the year. Some would be at the morning Church hour; some on third Sunday evenings following the fellowship supper.

In January, a general program giving information about the doctrines and beliefs of Methodism, and details (on posters) showing the combination of the five denominations rooted in Methodism into the United Methodist Church. A filmstrip highlighting the lives of John Wesley and Francis Asbury was also shown.

In February many of the congregation attended the District Bicentennial Rally in Wilmington at Kenan Auditorium where Burgaw's banner made by Mrs. Mickey King, Mrs. Ellen Wells, Mrs. Henrietta Jackson, and Mrs. Nellie Freed was displayed along with those of other Churches. The banner, illustrating Wesley's words "The World is My Parish" was beautifully designed and constructed.

In March, the Choir directed by Mrs. Mary Peedin, with Mrs. Florence Croom at the organ, led the congregation in "A Great Day of Singing." The program began with narrators Charles Rooks and John Federonko giving John Wesley's "Rules for Singing," still good advice for any congregation! Charles Wesley's hymns were used, also some of the congregations favorites.

The children took part in a Church Service in May with special songs and scripture verses. Mrs. Joyce Wooten spoke about John Wesley's work with Children. Following the service a picnic lunch was enjoyed. A huge cake topped by a circuit rider was served for dessert.

In June The United Methodist Women present "The Continuing Story", an orignal dramatization of the developing role of women in the American Methodist Church and in the local Church. It was written by Mrs. Eleanor Casey.

Mrs. Thel Overman of Wallace who attended the Bicentennial General Conference in Baltimore this year came to this Church and gave a report on the Conference following the fellowship supper in July. The men of the Church in charge of Laity Sunday invited Charles Sneeden, District Lay Leader to speak in October.

On October 21, at 7:30 P.M. the Church was favored by a visit by Rev. P. D. Midgett III of Southport United Methodist Church and his family. Rev. Midgett presented, in costume, a monologue on the life and activities of Wesley and the Methodist movement which started in London.

Homecoming on November 4, will have as main speaker Dr. H. Allen Norris, President of Louisburg College. Dr. Norris is the grandson of O. P. Johnson who was an early member, steward and trustee of this Church. It is hoped that several past ministers will attend. W. C. Blackmore is Homecoming chairman.

The year's celebration will come to a close with a Christmas Eve Communion Service in commeration of that first service of the Methodist Episcopal Church in Baltimore, December 24, 1784.
