- <u>* DURHAM, ASBURY TEMPLE: Corner of Lawson Street and Wabash Street; Founded in January, 1947 according to local church information; Earliest deed is for Cosmopolitan Methodist Church, September 22, 1951, Book 204, Page 108; Became Asbury Temple in 1954; Formerly Methodist Episcopal; Membership 69.</u>
- * DURHAM, <u>BETHANY:</u> 2809 Guess Road; Founded in 1892 according to local church information; Earliest deed October 27, 1892, Book 13, Page 433; Originally Warrens Chapel, was Bethany by 1927; Membership 650.
- * DURHAM, BETHESDA: 2305 South Miami Boulevard; Founded August 25, 1957 according to local church records; Earliest deed February 17, 1960, Book 264, Page 396; Membership 108.
- * DURHAM, BRANSON MEMORIAL: Corner of Alston Avenue and Angier Avenue; Founded in 1897 according to "Durham County Methodist Churches," Coman; Earliest deed November 21, 1904, Book 31, Page 497 for land whereon the church then stood; An identical deed recorded in Book 44, Page 180; Branson Church became Branson Memorial in 1923; Membership 129.
- * DURHAM, CALVARY: Corner of Trinity Avenue and Elizabeth Street; Founded as a Sunday school mission about 1880 and became Methodist affiliated in 1902 according to a printed history; Earliest deed January 31, 1906, Book 34, Page 145 for Mangum Street Methodist Church; Became Calvary in 1916; Membership 397.
- * DURHAM, CARR: Corner of East Main Street and Driver Street; Founded as East End Mission in December, 1885 according to Historical Sketches of Churches, Duke University Library; East End Mission organized as Carr, August 26, 1886; Earliest deed December 30, 1886, Book 7, Page 167; Membership 537.

- * DURHAM, DUKES CHAPEL: 807 Old Oxford Road; Founded in 1840 on the plantation on William J. Duke according to a printed history; Earliest deed is for Mount Hebron Methodist Church, December 31, 1879, Book 46, Page 315 in Orange County Registry; Another deed July 31, 1885, Book 3, Page 594 in Durham County Registry; Became Dukes Chapel in 1885; Membership 322.

- * DURHAM, MASSEYS CHAPEL: On Fayetteville Road near the Chatham County line; Founded in 1855 according to "Durham County Methodist Churches," Coman; Earliest deed April 4, 1856, Book 10, Page 543; Membership 37.
- * DURHAM, MAYBROOK: On Riddle Road near Ellis Road; Founded in 1949 according to "Durham County Methodist Churches," Coman; Earliest deed August 18, 1947, Book 175, Page 494; Membership 24.
- * DURHAM, McMANNEN: 4110 Neal Road; Founded about 1870 according to local church information; Earliest deed November 1, 1878, Book 47, Page 403 and recorded March 28, 1914 in Durham County Registry; Membership 415.
- * DURHAM, MOUNT SYLVAN: 5731 Roxboro Road; Founded in 1885 according to local church information; Earliest deed December 23, 1891, Book 20, Page 595; Membership 744.

- * MOUNT TABOR: On County Road 1607 three miles northeast of the Bahama Community; Founded in 1873 according to local church information; Earliest deed March 1, 1888, Book 134, Page 10 recorded August 4, 1939 for land whereon the church then stood; Membership 122.
- * RIVERVIEW: On County Road 1628 one mile east of U.S. Highway 501; Founded in 1898 according to local church information; Earliest deed December 2, 1899, Book 21, Page 222 for land whereon the church then stood; Formerly Orange Factory Methodist Church as early as 1884; Membership 21.
