- * BETHEL: On County Road 1613 three miles from the Vance County line; Founded in 1831 according to local church information; Earliest deed July 31, 1895, Book 52, Page 316; Membership 109.
- * BULLOCK: On U.S. Highway 15 two and a half miles north of Creedmoor; Founded in 1832 according to local church information; Earliest deed September 14, 1833, Book 12, Page 408; Membership 30.
 - COMMUNITY: 405 West "E" Street in the Town of Butner; Founded April 14, 1948 according to local church records; Earliest deed April 11, 1957, Book 145, Page 375; Membership 124.
- * CREEDMOOR: 213 Park Avenue in the Town of Creedmoor; Founded about 1915 according to local church information; Earliest deed April 10, 1913, Book 68, Page 62; Membership 283.
 - GRAY ROCK: On County Road 1622 between Banks and Bethel Churches; Founded in 1835 according to a church bulletin; Earliest deed April 10, 1923, Book 82, Page 71; A declaration in 1964, Book 161, Page 143 says "the church has stood in its location many, many years" and sets forth the present bounds of the property; Membership 103.
- * GROVE HILL: Just off County Road 1625 one mile from the Franklin County line; Founded in 1840 according to a church deed; Earliest deed June 10, 1840 recorded December 9, 1890, Book 44, Page 325; Membership 59.
- * OXFORD: Corner of College Street and McClanahan Street in Oxford; Founded in 1815 according to a church history; Earliest deed December 24, 1821, Book 1, Page 236 for the lot whereon the church then stood; Membership 785.
 - OXFORD, SAINT PETERS: Corner of Linden Avenue and West Front Street; Founded about 1877 according to a Conference history; Earliest deed April 3, 1876, Book 30, Page 426; Formerly Methodist Episcopal; Membership 155.

- * SALEM: On County Road 1522 one mile west of the Vance County line; Founded in 1828 according to a church history; Originated as Harris Meeting House August 16, 1811, Book V, Page 329; A division in 1828 resulted in the formation of Salem Meeting House in Granville County and Rehoboth Meeting House in Vance County; Harris Meeting House dismantled and rebuilt as Salem; Earliest deed September 13, 1845, Book 14, Page 47; Membership 158.
- * STEM: On County Road 1132 in the Community of Stem; Founded in 1888 from Moores Chapel which existed prior to 1790 according to a church history; Earliest deed registered February Court, 1822, Book 1, Page 151 for Moores Meeting House; Earliest Stem deed July 30, 1888, Book 42, Page 235; Membership 91.

STOVALL: Community of Stovall; Founded in 1910 according to local church information; Earliest deed March 15, 1909, Book 62, Page 407; Membership 29.

TRINITY: Near the intersection of County Roads 1311 and 1316 at the Person County line; Founded in 1820 according to church records: Earliest deed October 31, 1917, Book 74, Page 206; Membership 178.

ZORA CHAPEL: Intersection of U.S. Highway 15 and County Road 1445 three miles south of the Virginia State line; Founded in 1904 according to local church information; Formerly Methodist Episcopal; Earliest deed March 22, 1877, Book 31, Page 178; Membership 89.

CALVARY: Earliest deed August 5, 1905; Book 58, Page 291; Methodist Episcopal, South.
