- \* LEBANON: On County Road 1225 at the Wayne County line; Founded before 1808 according to a county history; Earliest deed September 29, 1887, Book 18, Page 354; On the Fremont Circuit in 1873; Membership 72.
- \* MAURY, BROOKS FRIZZELLE MEMORIAL: On State Road 102 in the Town of Maury; Founded in 1947 as Brooks Frizzelle Memorial Church by merger of Maury Church and Ormonds Chapel according to local church records; Maury deeded November 27, 1915, Book 94, Page 183 and Ormonds Chapel redeeded May 25, 1933, Book 175, Page 205 after the original deed was destroyed in a courthouse fire in 1875; Ormonds Chapel property was sold October, 1947, Book 239, Page 558; Earliest deed on Brooks Frizzelle Memorial in 1947 is Book 239, Page 538; Membership 179.
- \* MOUNT HERMAN: Intersection of County Road 1301 and U.S. Highway 13; Founded by 1887 according to a church deed; Earliest deed November 25, 1887, Book 18, Page 374; On Snow Hill Circuit about 1837; Formerly Sandy Run church; Membership 97.
- \* RAINBOW: On State Road 58 five miles south of Snow Hill; Founded in 1787 according to local church information; On Trent Circuit in 1796; Earliest conveyance a quit-claim deed March 15, 1888, Book 12, Page 432; Membership 341.
- \* SNOW HILL, CALVARY MEMORIAL: 103 West Greene Street in Snow Hill; Founded about 1810 according to a church history; Earliest deed July 18, 1959, Book 323, Page 442 after the original deed was destroyed in a court house fire in 1875; Membership 377.
- \* TABERNACLE: On County road 1232 one half mile north of the intersection of County roads 1225 and 1229 three and a half miles from the Wilson County line; Founded before 1810 according to Historical Papers of the North Carolina Conference Historical Society, 1925, p. 8; Earliest conveyance a quitclaim deed April 21, 1947, Book 239, Page 461 from surrounding landowners; Membership 89.
- \* WALSTONBURG: Town of Walstonburg; Founded in 1933 according to a county history; Earliest deed December 6, 1933, Book 175, Page 270; Membership 51.
