- <u>* CARTHAGE:</u> On Elm Street in Carthage; Founded as Burkhead Meeting House one mile west of Carthage in 1820 according to local church information; Earliest deed January 1, 1852, Book 16, Page 587 recorded November 26, 1898; Membership 305.
- * COOL <u>SPRING</u>: On County Road 1628 two miles southwest of Glendon; Founded by 1860 according to a church deed; Earliest deed February 25, 1860, Book 24, Page 679 recorded July 24, 1902; Membership 156.

DOUBS CHAPEL: On County Road 1229 five miles southwest of Carthage; Founded in October, 1900 according to local church information; Earliest deed February 1, 1900, Book 22, Page 306; Membership 147.

EAGLE SPRINGS: On County Road 1140 one and a half miles south of the community of Eagle Springs; Founded in 1874 according to a stone monument; Ealriest deed March --, 1890; Book 2, Page 271 for land on which the church was situated; Membership 66. <u>*</u> FAIR PROMISE: On County Road 1106 one and a half miles north of Glendon; Founded in 1814 according to a county history; Earliest deed May 3, 1890, Book 3, Page 33; Membership 115.

HIGH FALLS: On County Road 1606 just off State Road 22 in the Community of High Falls; Founded about 1890 according to a personal recollection; Earliest deed December 12, 1891, Book 6, Page 570; Membership 150.

MOUNT CARMEL: Intersection of County Roads 1261 and 1264 seven miles west of Carthage; Founded in 1883 according to local church information; Preaching appointment on the Deep River Circuit in 1859; Earliest deed October 19, 1874, Book 52, Page 162 recorded in 1912; Membership 67.

PAGE MEMORIAL: Corner of Main Street and Poplar Street in Aberdeen; Founded in 1889 according to a printed history; Earliest deeds February 10, 1891, Book 9, Page 423 and 425; Membership 557.

<u>PINEBLUFF:</u> Community of Pinebluff; Founded January 14, 1906 according to local church information; Earliest deed April 10, 1906, Book 37, Page 225; Membership 233.

* PLEASANT HILL: On County Road 1484 three miles southwest of High Falls; Founded in 1860 according to local church information; Earliest recorded deed Book 131, Page 38 registered July 25, 1939; Earliest church deed August 11, 1942, Book 139, Page 496 and August 13, 1942, Book 139, Page 495 for land originally given in 1861; Membership 326.

ROBBINS, TABERNACLE: Corner of Church Street and Carthage Road in Robbins; Founded in 1834 according to local church information; Earliest deed August 16, 1905, Book 33, Page 286 for land whereon Tabernacle Church at Elise then stood (Town of Elise became Hemp and then Robbins); Membership 575.

<u>*</u> ROSELAND: On County Road 1112 in the Community of Roseland; Founded September 24, 1939 according to the Page Memorial Church records; Earliest deed November 27, 1899, Book 20, Page 498; Named First Methodist Church in Roseland in 1912, Book 52, Page 208; Membership 67.

SMYRNA: Intersection of County Roads 1419 and 1457 two miles south of the Randolph County line; Founded in 1834 according to local church information; Earliest deed April 23, 1904, Book 111, Page 520 (This deed covers an old deed plus one and a half acres known as Smyrna Church lot) recorded October 20, 1932; Membership 454.

SOUTHERN PINES: 175 Midland Road in Southern Pines; Founded June 13, 1954 and organized September 12, 1954 according to a church history; Earliest deed March 29, 1955, Book 187, Page 529; Membership 541.

- * VASS: On Alma Street in Vass; Founded by 1884 according to a church deed; Earliest deed November 15, 1884 (This deed was destroyed by fire in 1889); Deed for another parcel of land was given December 12, 1902, Book 29, Page 111; A quit-claim deed was given for both tracts on February 1, 1933, Book 115, Page 422; Formerly Johnson Grove Church; Became Vass about 1918; Membership 210.
