<u>WATER:</u> On County Road 1318 at Watha; Founded in 1900 according to a church history; Earliest deed June 17, 1907 Book 56, Page 73; Membership 63.

* WESLEYAN CHAPEL: On U.S Highway 17 at the New Hanover County line; Founded in 1824 according to Circuit Minutes; The church was dedicated August 23,1874; Became Wesleyan Chapel by 1910 according to a church deed; Earliest deed January 7, 1850, Book II, Page 438 New Hanover County Registry; Another deed November 10, 1873, Book B, Page 13; Scotts Hill Mission named in Conference Minutes in 1854; Membership 86.

<u>WESTVIEW:</u> On State Road 53 five miles west of Burgaw; Founded May 10, 1964 according to local church records; Earliest deed April 1, 1964, Book 381, Page 293; Membership 87.
