<u>HELENA:</u> On County Road 1715 in the Community of Timberlake; Founded in 1900 according to local church information; Earliest deed March 21, 1904, Book 5, Page 24; Membership 166.

LEAS CHAPEL: On U.S. Highway 158 three miles east of the Caswell County line; Founded as an Anglican Chapel in 1750, Became Methodist related in 1784 according to local church information; Earliest deed March 11, 1835, Book 78, Page 495 recorded June 7, 1957; Membership 108.

MOUNT <u>TIRZAH:</u> On County Road 1715 near the intersection with County Road 1717 two miles east of the Community of Timberlake; Founded by 1819 according to a church deed; Earliest deed November 10, 1819, Book E, Page 246 for land whereon the meeting house then stood; Membership 64.

* MOUNT <u>ZION:</u> On County Road 1133 just off State Road 157 three miles north of Hurdle Mills; Founded by 1786 according to records at Flat River Baptist Church and known as Hargis Meeting House; Methodist related by 1835; Earliest deed December 9, 1835, Book M, Page 56; Membership 276.

OAK <u>GROVE:</u> On County Road 1335 just north of County Road 1337 in the Chub Lake Community; Founded in 1828 according to a church deed; Earliest deed July 17, 1828, Book K, Page 79; Membership 332.

<u>ROXBORO, CA-VEL:</u> On U.S. Highway 501 and CountyRoad 1326 in north Roxboro; Founded February 5, 1938 according to local church records; Earliest conveyance a lease February 6, 1958, Book 81, Page 109; Membership 173. <u>ROXBORO, GRACE:</u> 313 Church Street; Founded in 1916 according to a cornerstone and local church information; Earliest deed for Edgar Long Memorial Church of Roxboro November 27, 1916, Book 25, Page 87; Formerly East Roxboro, became Grace by 1957; Membership 281.

ROXBORO, LONGHURST: On Providence Road in the Longhurst Community; Founded in 1915 according to a cornerstone and local church information; Earliest deed January 31, 1917, Book 25, Page 203; Membership 291.
