PREFACE

When the Carolina Circuit was formed in 1776, three preachers——Edward Dromgoole, Francis Poythress and Isham Tatum——were appointed by Bishop Francis Asbury to serve all of the territory south of Virginia. At that time there were no church buildings, no parsonages, no educational institutions and very few Methodists.

Sixty years later Methodism had expanded and developed so much that the General Conference of the Methodist Episcopal Church in May 1836 authorized the establishment of a new annual conference, the North Carolina Conference, which included most of the state. Therefore, when the Virginia Conference met in Petersburg, Virginia, in February 1837, the division of the conferences took place, and the pastoral appointments for North Carolina and Virginia were listed separately for the first time.

The northeastern section of the state (Murfreesboro, Gates, Edenton, Elizabeth City and Camden Circuits) remained in the Virginia Conference, while the Danville area of Virginia was included in the North Carolina Conference for several years. The southern portion of the state, from Wilmington to Charlotte, was in the South Carolina Conference; while the area west of the Blue Ridge Mountains was a part of the Holston Conference. A look at the map will make one realize what effect the geography of the state had on conference boundaries at this time. It was not until 1890 that all of North Carolina territory was transferred to the North Carolina Conference, and the work was then divided into two conferences—North Carolina and Western North Carolina.

There were sixty preachers who were assigned to the North Carolina Conference in 1837. Five of these had already retired, five were appointed as Presiding Elder (District Superintendent), and the other fifty were appointed to the forty-four pastoral charges or to a special appointment beyond the local church. These sixty "Charter Members" deserve special recognition, I think, as we celebrate our sesquicentennial. Their ministry spans more than one hundred years (1790-1896).

In this booklet I have collected their pastoral records and information about the men and their families. Unfortunately, the early records are somewhat scarce, so there are quite a few gaps. When a minister "located" or dropped out of the ministry, there were no further records kept on him. Perhaps some of you who read this may be able to supply some of the missing data for our conference archives.

The circuits in the first half of the nineteenth century were quite large, travel was extremely difficult and sometime hazardous, and the pay was very low. Few preachers could support a wife and children, so they usually "located" and went into other work. Sometimes it became necessary for a preacher to take the "Supernumerary" relationship while he tried to regain his health. But many of them, like Bennett T. Blake and William E. Pell, continued to preach and to serve in the local church, assisting the pastor in charge of the local church or circuit.

This booklet is dedicated to the memory of those pioneer Methodist preachers who blazed the trail, to the thousands of men and women who have followed in their footsteps, and to those who today still ask to be sent "where there are sinners." [Alfred Norman, 1828]

Other Information: He was converted in 1830 at Moss' camp ground; was licensed to exhort in 1831, and licensed to preach in 1831. He served 63 years as a Methodist minister, 40 of them as an itinerant pastor. He organized the church and station in Winston in 1854. Much of his ministry was spent in the Winston area, especially after he retired in 1873. The people in Winston loved him and called him "Uncle Albea".

Other Information: He was converted at camp meeting in Nelson County in 1825 under the ministry of Moses Brock. He was licensed to preach in 1828 and began work on the Greenville Circuit, assisting Moses Brock and G. W. S. Harper. In 1856 he was appointed steward of Greensboro Female College, and served with that institution until it was destroyed by fire. He continued to live in Greensboro until his death. He was much beloved by the students at GFC, who fondly called him "Uncle Bethel".

Family: Parents: Ellis Gray and Mary (Taylor) Blake. Lineal descendant of Robert Blake, distinguished admiral. His grandfather was Benjamin Blake. A brother, Nathaniel Oliver, was a Methodist preacher and newspaper publisher in Nashville, TN.

<u>Married</u>: (1) Feb. 21, 1828 to Setna (Fetney) Price, daughter of Thomas Needham and Rebecca (Robertson) Price of the Shotwell community in Wake Co., NC. She died Jan. 22, 1836.

<u>Children</u>: Laura Ann (mar. William C. Doub, son of Rev. Peter Doub, and professor at Greensboro Female College); Mary Rebecca; John Gray; Bennett Taylor, Jr. (fell dead on street in Raleigh).

(2) Feb. 18, 1837 to Mrs. Scheherazade Price Mial (She was sister of his first wife and widow of Alonzo Thomas Mial). She died May 25, 1853. Children: One son, Joseph (mar. Lucy Carolina Person).

Most members of the family are buried in Oak Grove Church Cemetery, next to the Price homestead, which is still standing. Blake willed the house to his grandson, Lander Doub; it is known today at the Doub House.

Other Information: His father moved from Boston, MA, to Southampton Co., VA, the latter part of the 18th century. When Bennett was 8, his family moved to Petersburg. His mother died in 1811, his father in 1815. Blake worked as clerk in large mercantile store in Petersburg. Attended Episcopal Church some and Meth. Church. Converted 1822 under preaching of H. G. Reluctant to answer call to preach. John Early, his PE (later bishop), told him: "Get your saddlebags, young man; get your saddlebags." In 1834 he took the supernumerary relationship in the conference so he could manage his personal business (he operated a store and had extensive farming interests) and could apply his talents in new directions. He helped to establish new congregations (Oaky Grove and Ebenezer). The Neuse River Mission to People of Colour was begun by him in 1844, and he organized Sunday School for religious instruction of blacks. He had a very benevolent attitude toward slaves. [Grill: Early Methodist Meeting Houses in Wake County, passim; and Personal Interview with Mrs. Julia Sanders Eller.]

In 1837 he was a member of the committee to petition the State legislature to charter what became Greensboro Female College. He became a member of its first Board of Trustees and faculty. In 1846 he sold 100 bales of cotton and used money to buy furniture for the college. [Carroll: <u>They</u> Lived in Raleigh, I:97-98]

Upon his return to Raleigh he helped found Raleigh Female Seminary on Hillsborough Street. During the 1850's he taught there and was principal for a While.

Blake was delegate to General Conference in 1832 and 1844, and of the Louisville Convention which organized the MECS in 1845.

It was Doub who proposed the name Methodist Episcopal Church, South, which was adopted. His early circuits were very large; e.g., the Raleigh Circuit in 1869 extended from Wake County to Goldsboro, Wilson, and Kinston. Many young men were led into the ministry by him. Doub's Chapel in Forsythe Co. was dedicated in 1852, and his son, Peter, preached. "Few men were more successful in swaying the minds of the community and in leading converts into the church." [Edenton Street in Methodism, 1811-1961, p. 10-11] He did not like to expel people from the church, but only after all efforts had failed. He was elected to every General Conference from 1820 on. He was a member of the Louisville Convention in 1845 which organized the Meth. Episcopal Church South. He stood firmly with the South on church division. His greatest contribution probably was in the field of Christian higher education. While serving in Petersburg he began efforts to establish a college to train preachers in Virginia. Randolph-Macon College was chartered in 1829, located in Mecklenburg Co., VA (later relocated in Ashland). He located near the school and served as one of the first agents for that institution. He also served on the Board of Trustees for many years. The College honored him with a D.D. shortly before his death. After his death the NC Conf. erected a commemorative plaque at Randolph-Macon. He also served on the committee appointed to establish what became Greensboro Female College, chartered in 1838, and was a member ot its first Board of Trustees. [Thomas O. Other Information: Reid was one of the few preachers of his day to overcome the opposition from Asbury and others that married preachers should not itinerate. He helped to change that attitude. The General Conf. of 1870 authorized the transfer of the circuits in the lower part of of the state from the SC Carolina to the NC Conference. Bishop James Andrew strongly opposed this boundary change. "Uncle Reid" helped to smooth the dissension this caused in the 1851 session of the NC Conf. in Salisbury. He was elected delegate to the 1833 General Conf. in Philadelphia. He also was trustee of Greensboro Female College. He was a member of the committee which petitioned the NC Legislature in 1837 to charter Greensboro Female College and served on its first Board of Trustees. In 1852 he moved his family to Louisburg, NC, and served much of the remainder of his time from that home base. He was so highly regarded throughout the entire state that in 1872 he was elected Supt. of Public Instruction for the State of NC, but died before he could take office. He consented to have his name placed in nomination for the position, but he made no speeches and did no canvassing or campaigning. Reid died in his sleep at the home of Rev. N. H. D. Wilson in Greensboro. He was buried in Louisburg beside his first wife and two sons.
