- <u>* LUMBERTON, CHESTNUT STREET:</u> Corner of Chestnut Street and Eighth Street; Founded between 1787 and 1803 according to a printed history; Congregation may have been meeting in an academy building when the town was founded in 1788 according to references made by Francis Asbury; Earliest deed February 17, 1830, Book U, Page 377; Formerly Lumberton Methodist Church, became Chestnut Street in 1906; Membership 1,214.

<u>MOUNT</u> ZION: On County Road 1318 less than a mile from the Hoke County line; Founded in 1868 according to a church deed; Earliest deed October 2, 1868, Book MM, Page 395; Formerly Methodist Episcopal; Membership 142.
