A. Present Churches

* CRESWELL: On Sixth Street in the Town of Creswell; Pounded in 1893 according to a church deed; Earliest deed is for a Methodist Protestant Church September 6, 1893, Book 33, Page 440; Another deed May 9, 1921 is for an M.E. Church, South, Book 76, Page 590 for land on which the church then stood; These churches merged in 1939 with the M.E. Church, South property retained; Membership 58.

MACKEYS: Junction of County Roads 1300 and 1321 in the Community of Mackeys; Founded in 1908 according to local church records; Earliest deed December 1, 1908, Book 56, Page 52; An earlier deed for land in the same area deeded to the Methodist Protestant Church July 16, 1850, Book K, Page 414; Membership 58.

* MOUNT HERMON: On County Road 1126 near the Community of Cherry; Founded in 1896 according to a church deed; Earliest deed November 24, 1896, Book 62, Page 392; Formerly Methodist Protestant; Membership 191.

PLEASANT GROVE: Junction of U.S. Highway 64 and County Road 1300; Founded in 1859 according to a church deed; Earliest deed July 1, 1859, Book 0, Page 405; Membership 42.

* PLYMOUTH: Corner of Third and Adams Street in Plymouth; Founded in 1827 according to local church information; William Ormond preached at Plymouth in 1796 while on the Trent Circuit; Earliest deed August 3, 1832, Book G, Page 434; Membership 531.

ROPER, HEBRON: On U.S. Highway 64 in the Town of Roper; pounded in 1824 according to a church history; Earliest deed December 4, 1824, Book F, Page 201; Membership 83.

CRESWELL: Earliest deed September 9, 1893; Book 33, Page 439; Methodist Protestant.

PLYMOUTH: Earliest deed May 7, 1896; Book 36, Page 103; Methodist Protestant.

REHOBOTH: Earliest deed July 16, 1850; Book K, Page 414; Methodist Protestant.

SALEM: Earliest deed July or August 1872; Book 30, Page 522; Methodist Protestant.

SCUPPERNONG: Earliest deed September 11, 1905; Book 47, Page 596; Methodist Episcopal, South.

* CRESWELL: On Sixth Street in the Town of Creswell; Founded in 1893 according to a church deed; Earliest deed is for a **Methodist** Protestant Church September 6, 1893, Book 33, Page 440; Another deed May 9, 1921 is for an M.E. Church, South, Book 76, Page 590 for land on **which** the church then stood; These churches merged in 1939 with the M.E. **Church**, South property retained; Membership 58.

MACKEYS: Junction of County Roads 1300 and 1321 in the Community of Mackeys; Founded in 1908 according to local **church** records; Earliest deed December 1, 1908, Book 56, Page 52; An earlier deed for land in the same area deeded to the Methodist Protestant **Church** July 16, 1850, Book K, Page 414; Membership 58.

* MOUNT HERMON: On County Road 1126 near the Community of Cherry; Founded in 1896 according to a church deed; Earliest deed November 24, 1896, Book 62, Page 392; Formerly Methodist Protestant; Membership 191.

PLEASANT GROVE: Junction of U.S. Highway 64 and County Road 1300; Founded in 1859 according to a church deed; Earliest deed July 1, 1859, Book 0, Page 405; Membership 42.

* PLYMOUTH: Corner of Third and Adams Street in Plymouth; Founded in 1827 according to local church information; William Ormond preached at Plymouth in 1796 while on the Trent Circuit; Earliest deed August 3, 1832, Book G, Page 434; Membership 531.

ROPER, HEBRON: On U.S. Highway 64 in the Town of Roper; Pounded in 1824 according to a **church** history; Earliest deed December 4, 1824, Book F, Page 201; Membership 83.
