

2026 Health Reimbursement Account (HRA) Funding

The HRA arrangement will continue in 2026. Please refer to the below chart about the funding amount. Any unused funds in the HRA will carry forward into 2026 and will be added to the 2026 approved amount. Participants may contact Via Benefits at 855-801-9759 to inquire about their specific HRA amount, balance or to claim reimbursements.

Each participant's specific HRA Contribution is based upon their individual retirement criteria. Based on the rules in place at the time of their retirement, their percentage may be slightly different than those in this chart.

The approved 2026 HRA funding amount is based on a beginning funding rate of \$4,568. Participants should apply their percentage to this figure for calculation of their 2026 HRA amount. A single account will receive one 2026 HRA contribution. A joint account (retiree and spouse) will receive two 2026 HRA contributions.

Example:

- * Retiree received \$2,661 in 2025 (60%).
- * Spouse of retiree received \$2,661 in 2025 (60%).
- * Total joint account in 2025 was \$5,222.
- * In 2026, the retiree and spouse will receive a joint account in the amount of \$5,482 (\$2,741 + \$2,741).
